The school reserves the right to deny reenrollment of any student who does not meet its academic requirements or fails to conform to its rules and regulations.

The Admissions and Student Affairs Committee makes these decisions only after full discussion with the student's teachers and administrators. If a student is not reenrolled before the 2010-2011 academic year begins, all or a portion of the admission process may be required for that student.

Statement of Faith

1. We believe that the Bible is the very Word of God in its entirety and, therefore, is our authority in matters of faith and practice.
2. We believe in one God, Creator of the universe, eternally existing in the persons of the Father, the Son, and the Holy Spirit.

5. We believe that Jesus Christ ascended into Heaven to the right hand of God the Father and will one day return to this earth in power and glory.
6. We believe that the only means of being cleansed from sin is through repentance and faith in the precious blood of Jesus Christ, surrendering to Him as Lord and Savior.
7. We believe that the Holy Spirit is a personal Being who convicts the world of sin and who regenerates, indwells, empowers, guides, and seals believers eternally for God.
8. We believe that regeneration by the Holy Spirit is absolutely necessary for the salvation of lost sinners, and those who receive the Lord Jesus Christ by faith are born again into the family of God.
9. We believe that heaven is the abode and the place of eternal joy for the saved, and that hell is the place of eternal punishment for the lost.
10. We believe that the family of God is part of the visible church, and is the body of believers of which Christ is the head.

The Statement of Faith contains those doctrines to which the school unreservedly adheres and teaches. It is the school's desire to maintain this position. Although Trinity Christian Academy is a ministry of Tates Creek Presbyterian Church, students are not required to believe our denominational distinctives as set forth in the Westminster Confession of Faith. However, these matters may arise in classes and chapel services and are part of the Upper School Bible curriculum.
